# Service Name: Early Help

This notice provides additional privacy information for: Families who require the help of a range of council services.

# Purpose(s)

The council and its partner organisations are working closely to ensure that services are more joined up. To help us do this, we collect and obtain your personal information for the following purpose(s):

- · to identify children, young people and families who may need help and support
- to understand and meet the needs of children, young people and families
- to ensure services across a range of organisations are coordinated and focussed on children, young people families with the most pressing and complex needs
- to participate in local and national research to assess how well the services are working in delivering better long-term outcomes for children, young people and families and in making services more effective
- to meet government requirements to deliver the national Supporting Families

# **Categories of personal data**

In order to carry out these purposes we process the following categories of personal data:

- Name, address and contact details
- Date of Birth/Age
- Gender
- Ethnicity/Nationality/Country of birth
- Religion
- NHS number
- Education details including attendance and attainment data
- Social care status
- Housing status
- Health data such as mental health, drug or alcohol abuse/dependency
- Details of criminal activity
- Financial data, such as rent arrears

# Lawful basis for processing

#### UK GDPR Article 6:

(e): the processing is necessary to perform a task in the public interest or for official functions, and the task or function has a clear basis in law - Sections 10 and 11 of The Children's Act 2004 UK GDPR Article 9:

(g) processing is necessary for reasons of substantial public interest

(h) processing is necessary for the provision of social care

**UK GDPR Article 10:** The council relies on Schedule 1, Part 1 (1) of the Data Protection Act 2018 to process criminal offence data.
